

Priority 1 Hazard- Recommendations #1: Head & Neck Entrapment. Contact <u>Northwest Playground</u> <u>Equipment | Commercial Playground Equipment & Design (nwplayground.com)</u> to replace tic-tac-toe panel.



Priority 1 Hazard- Recommendation #2: Severely low safety surfacing. Add additional pea gravel to the entire

play area. Add additional 6" of surfacing (pea gravel).



Priority 2 Hazard-Recommendations #3: Lack of a use zone. The swing requires 20' of use zone to and fro. Remove swing and replace with a shorter swing that does not require so much space.



Priority 2 Hazard-Recommendations #4: Lack of a use zone. The arch climber requires a 6' use zone. Add an additional 14" of required use zone.





Priority 2 Hazard-Recommendations #5: Remove or replace the old rocker. It has a dangerous crush and shear

area.



Priority 2 Hazard-Recommendations #6: Remove overhead obstruction by trimming back branches 7' from the top of the play structure.



Priority 3 Hazard-Recommendations #7: Low level powerwash all plastics.
